Dear MA Families,

The Board held a Safety Information work session on March 3, 2022. Thank you to the staff and parents who attended the meeting. The questions and comments from the MA community were extremely valuable. For those who couldn't participate, please review the information below.

We value your engagement in this critical discussion.

The Board invited the following panelists to a discussion surrounding school safety: Laura Carno, representing FASTER Colorado; Brian Rea, Superintendent, Peyton School District 23; Mr. & Mrs. John Castillo, parents of Kendrick Castillo; Brad Miller, Legal Counsel, Miller Law Firm; Mr. Merlin Holmes, COO, MA; and Mrs. Angela Duca, AP MA East.

Mr. John Castillo told the story of his son, Kendrick Castillo, who martyred his life when he rushed a school shooter at the STEM School in Highlands Ranch in May 2019. Mr. Castillo not only advocates for the FASTER program and having armed staff in schools, but also for closed school campus policy, and intentional connection as human beings. The Board was honored to have Mr. & Mrs. Castillo in attendance and thanks them for their strength and bravery.

The discussion focused on school shootings and keeping our children safe through prevention and rapid response in part by participating in the Faculty/Administrator Safety Training and Emergency Response (FASTER) program. Mr. Brian Rea from Peyton School District 23 gave the Board and MA Community a snapshot of how Peyton schools have successfully implemented this program.

FASTER training enables teachers, administrators, and other school employees to stop school violence quickly and administer medical aid immediately. FASTER is not intended as a replacement for Police and EMTs. Instead, it enables on-site personnel to save lives through prompt action.

We encourage every parent and staff member to review the information related to this program. The Board will be sending a short survey to all MA staff and parents asking for your opinion on whether the Board should move forward with a policy to allow highly trained staff to conceal carry at each campus.
