COO Update

The school is considering Before and After School care with an organization called Leading Edge. The board has asked school legal counsel to review the Memorandum of Understanding. This is the same organization being utilized by D38. If approved, service would start after Monument Academy has received its licensing from the State, which is expected to take another 4-6 weeks. The program has a cap of 75 students and is for ages 5-12 years. The MOU will be discussed further at the September 8th, 2022 Board meeting.

Highway 105 Recirculation Plan Update

Monument Academy has been diligently working to procure a bid from a contractor this summer for the car-line recirculation plan. Monument Academy advertised the project two separate times this summer and both times were unsuccessful in receiving a bid. Therefore, the project request for proposal will go out for advertisement a third time this Fall.

- Meet with 1-2 Board members to ask questions about the position

- Give a 5-minute statement of interest at the board meeting
- Community Q&A session with applicants

Sept 8th, 2022 Regular Session Board Meeting, 6pm in the East Campus Gym

- The Board will hold a closed ballot vote with the announcement of the new director appointment if (2) or more applications are received.
- New director will be sworn in and will commence with the vacancy term which will only be through June 30, 2023.
